## Test values

## Processing note

Under the recommended processing conditions small quantities of decomposition product may be given off during processing. In order to prevent the partial decomposition of the polymer and the generation of volatile decomposition products, the prescribed processing temperatures should not be substantially exceeded. Since excessively high temperatures are generally the result of operator error of defects in the heating system, special care and controls are essential in these areas.
